Re: Changes to Input Specifications for CSS Registration Third Week, End of Term and Health Science Resident Files

## Dear Colleagues:

After consultation with Campus Registrars, UCOP is requesting the addition of **4 new data elements** to collect Gender Identity and Sexual Orientation information of students. Data collected on gender identity and sexual orientation will provide UC campuses with meaningful population data that will enable campuses to develop curricular and co-curricular offerings which reflect students' diverse perspectives, and promote a safe and welcoming learning environment for all students. These new data elements are mandatory for undergraduate populations effective fall 2016, and are also required for graduate and professional students once available.

In addition to this, existing element named "Sex Code", Ref No H020 will continue to capture current Gender data.

These changes are effective for the summer 2016 Enrollment Third Week file due on September 15, 2016.
