Campuses may begin including the new codes on the Fall Term (Fall Semester) Third Week Enrollment File, but inclusion of the revised codes will not be required until submission of the Fall Term (Fall Semester) End of Term Enrollment File.

The modified element is:

- H310 -- Special Programs Code - Registration

A revised data element definition for H310 is attached. The modified element will continue to be reported in position 132-137 on the third week and end of term enrollment files.
