Re: Changes to Input Specs for CSS Third Week and End of Term Registrant Files

Dear Colleagues:

After consultation with the campus Registrars, UCOP is requesting the addition of seven new data elements to the CSS Third Week and End of Term Registrant files. These new data elements will allow the principal users of registrant data at UCOP (Budget Office, Student Financial Support, Academic Strategic Planning & Analysis, Academic Advancement, and Admissions Research & Evaluation), and possibly the campus IR directors, to assess student progress more accurately and to be fully compliant with state and federal reporting requirements. The changes are to be effective as of the Summer 2007 submissions.

3. Data Definitions

Units Credited by Exam – AP (Advanced Placement) Units Credited by Exam – IB (International Baccalaureate) Units Credited by Exam – UC Units Credited from CCC (California Community Colleges) Units Credited from Other Non-UC (Non-UC institutions other than CCC) Total units credited to the student's transcript, from each source. Provide at third week census date and end-of-term.

Non Degree Units Attempted - Curr

Units attempted during the current term in UC coursework which does not count toward a degree, but is counted for fee assessment and financial aid. Provide at third week census date and end-of-term.

Units Passed - TTD - P/NP UC - 3rd Week

The sum of the units for Pass/Not Passed and Satisfactory/Unsatisfactory courses passed at the current campus to date, as of the third week census date. This new data element is the third week pendant to existing element Units Passed-Total to Date- P/NP-UC-End of Term, ref. no. H540.

4. New Record Length

The addition of the new fields will require the registrant file record length to be increased. The **new record length** will be 275 bytes.

5. Scope

The new data elements are to be included in both summer and regular term files.

The new record length applies to all registrant files: Third Week, End of Term, Health Science Resident, summer and regular term.

6. Implementation Time Frame

Because these changes to the Registrant input specifications will require a substantial programming effort on the part of campus and UCOP staff, we are allowing more time than usual for implementation. The changes will take effect beginning with the Summer 2007 submissions.
