Schedule

Campuses should submit file every quarter from the UC campuses, the Office of the President, the Division of Agriculture and Natural Resources, and the Lawrence Berkeley National Laboratory

File Name: SPXPRP.Qyyy (in uppercase) where:

- q = quarter
- yy = fiscal year

Record Format: Fixed Length

Record Length: 686 [Any file with a different record length will be rejected]
