These fields will support UCOP's ability to accurately report, analyze, and model changes to student demographics and the impact of new aid policies and programs, including the shift from using the Expected Family Contribution to the Student Aid Index. Furthermore, the fields will enhance the Office of the President's ability to accurately distribute financial aid resources under the Education Financing Model (EFM). We recognize that you supply large amounts of data currently, and we appreciate your ongoing assistance and support of the EFM.
