Graduate Admissions File Overview

The graduate admission file contains data on all applicants for admission as graduate students in the Fall Quarter (Term). An applicant is defined as anyone who submits an appropriate application form and pays an application fee. This includes all professional school applicants who applied through an outside application vendor (e.g., AMCAS, PHARMCAS). The file must contain demographic and admission data on applicants. A Graduate Admission Record should be supplied for each applicant in the population.

Schedule: Campuses should supply this file for each Fall Term by the first of February.
